- (Which Expressions) shall unless repugnant to the context or meaning there of be deemed to mean and include his / her / their legal heirs, executors, administrators and assignees of both the parties.
- This contract is construed, agreed, signed and executed in accordance with the model guidelines on direct selling issued by the Govt. of India, Ministry of Consumer Affairs, Food & Public Distribution, Department of Consumer Affairs vide F. No. 21/18/2014-IT (Vol-II) dated 9th Sept, 2016 read with Indian Contract Act, 1872.
- The undersigned Distributor acknowledges that he / she has read, understood and accepted all the terms & conditions of this Application + Agreement Form and also agrees to comply by all the terms mentioned on the company's website www.weprowellness.com. The distributor also agrees to read and comply by further amendments, which will be made from time to time.
